To use advanced hunting, you need to have one of the following roles:

- ? Security administrator
- ? Security reader
- ? Security operator
- ? Global administrator

The Groups Administrator role does not have access to advanced hunting or Microsoft Defender ATP.

Therefore, based on this information, the correct answer is B. Assign the Microsoft 365 E5 compliance add-on to each user. This add-on includes Microsoft Defender ATP and allows you to use advanced hunting features³. Alternatively, you can request one of the roles that have access to advanced hunting, such as Security administrator or Global administrator.




